APPROVE MINUTES:

Travis motioned to approve the February council minutes. Sarah seconded and the motion passed.

WATER PROJECT UPDATE:

Steven Wood couldn't make it to the meeting but he asked the council to make a decision about how many fire hydrants to order with the remaining project funds. Travis motioned to purchase 12 additional fire hydrants (in addition to the four that were already included in the budget) and Scott seconded the motion. The voting was in favor.

MAYOR'S REPORT:

RESOLUTION 2021-1 FEE SCHEDULE:

The council voted to table passing a fee schedule resolution until the ordinances are codified.

TENNIS COURT PROPOSAL:

Camille Larsen sent an e-mail request to fix the cracks in the tennis court and turn a court into a pickle ball court. The mayor would like to use his mayor's walking challenge money for this. We need to see how much for sure it would cost and see if there's some young men who would like to do a service project.

BUILDING PERMIT CHECKLIST:

Sharon got the checklist that Dayton City uses when they are doing a lot split approval to see if it's something we could use for our building permit process. The council looked it over and decided it would be nice if the canal companies, the fire department, and the post office could all sign off on building permits.

NEW CITY TRUCK:

Glen found a 2012 Chevy single cab flatbed 3500 truck at West Motor. He had Thom Greene look it over and it needs a few repairs but overall is in good shape. It would cost \$17,000 but would need about \$5000 in repairs. Travis would like to wait and see about getting a medium size plow truck from Cache County next January. Scott also liked that idea. The council decided to table the discussion until Travis could find out more information about getting a Cache County truck. Sarah said she could also check with ITD to see if they have any surplus vehicles.

The bills and bank statement were passed around. Sarah motioned to approve the February bills. Ryan seconded and the motion passed.
